01. Educational Qualifications :

Should have passed General Certificate of Education (Ordinary Level) Examination with six (06) subjects including two (02) credit passes in not more than two sittings

03. Experience:

Minimum experience is not applicable. However, the experience gained in the relevant field is considered as an additional qualification.

04. Physical qualifications:

05. Age:

Should be not less than 18 years and not more than 45 years of age on the closing date of applications

06. Recruitment Qualifications:

- (i) Applicants should be citizens of Sri Lanka.
- (ii) Applicants should be of excellent character.
- (iii) All qualifications required for recruitment to the post should be accomplished, at the Closing date of calling applications.

07. Conditions of engagement in service:
