1. Having obtained a degree recognized by the University Grants Commission (UGC)

Having obtained a post graduate Degree (Masters) in the subject field of Management, Agriculture / Planning / Development / Social Sciences / Technology / Water Management / Associate Membership in a recognized chartered professional institution, in a subject field relevant to the post

and

Having obtained a minimum of fifteen years (15) experience in the field of Administration / Immigration / Water Management / Agriculture / Land / Development and Corporate Development, in a post of "Management" level, in the public service, state corporation / board / Statutory institution or in a recognized private institution.
