### Qualification:

Should be an Officer in Sri Lanka Administrative Service Class III or Sri Lanka Accountants Service Class III or Audit Inspector Service Class I or a Supra grade Officer in Public/Provincial Management Service Officers' Service.

### Experience

Applicant should have the experience in the field of accounts, establishment and administration and efficiency in Sinhala and English languages. Knowledge in Tamil language will be an added qualification.

### Conditions

Applications are invited for the above post from officers in Government service and Provincial Government Service and will be recruited on secondment basis on government requirement for a service period of two years as per Section No. 148 in Chapter 12 of the Procedural Rules of the Public Service Commission.

As this is an incorporated institution under the supervision of the Ministry of Finance, you may submit your application through Eleventh (XI) Appendix of the Procedural Rules of the Public Service Commission.

The selected applicant should submit a certification from the dept. head that he/she may be released for a period of two (02) years service in the Association as per the Procedural Rules of the Public Service Commission and / or the provisions of the Establishment Code of the Government of the Democratic Socialist Republic of Sri Lanka.
