CHIEF INTERNAL AUDITOR

The Chief Internal Auditor is responsible for the execution of the overall internal audit plan for the bank covering all aspects of its business that include:

- ❖ Carry out internal audit on bank's subsidiaries and associates as and when required.
- ❖ Interact with external auditor/s and government agencies including Central Bank of Sri Lanka with respect to the audit matters.
- ❖ Reviewing and appraising the economy and efficiency with which resources are employed.
- ❖ Support the business in achieving its corporate objectives. Identify activities that need improvement in procedures and /or policies so that business can be improved without increasing risks.
- ❖ Foresee potential areas of concern/risk and advise the top management on appropriate corrective action to be initiated.
- ❖ Create a culture within the bank whereby all personnel actively adopt best practices for reducing the risks to the bank.
- ❖ Develop, train and motivate the staff of Internal Audit Department through personal example & guidance & ensuring that they are continuously updated with the latest developments in banking/auditing techniques.

Key Requirements

- ❖ Possess a minimum of 10 years' Executive experience in a reputed Bank or Financial Institution out of which 02 years should be at Senior Managerial Level preferably in audit environment.

- ❖ A postgraduate qualification in a related field would be considered an added advantage.
