Applications are invited from suitably qualified persons for the following posts in the University of Peradeniya.

### 1) CURATOR (LANDSCAPE) GRADE III

**Salary Scale :** 50625-3x1125-54000(EB) 55335; 12x1335-71355 p.m. [U-EX I (II)]

**Qualifications :**

1. Should possess a four year Special Bachelor's Degree (Honours) in Agriculture or Agricultural Technology & Management and majoring in Crop Science/ Horticulture/ Floriculture / Forestry from a recognized university/ HEI with not less than one (01) year of experience in landscaping in a State/ Corporation or reputed Private Sector organization in supervisory capacity

**OR**

2. Should possess a four year Special Bachelor's Degree (Honours) in Landscape Architecture from a recognized university/HEI with not less than one (01) year of experience in landscaping in a State/ Corporation or reputed Private Sector organization in supervisory capacity

**OR**

3. Should possess a four year Special Bachelor's Degree (Honours) in Botany from a recognized university/ HEI with not less than two (02) years of experience in landscaping in State/ Corporation or reputed Private Sector organization in supervisory capacity.

**Method of Recruitment :**

Selection by a structured interview

**Age Limit :** Age limit will not apply. The compulsory retirement age of employees of the university service is sixty years. The selected candidate will be on probation for a period of three years or one year (for confirmed employees of the university system) reckoned from the date of assumption of duties.

### 2) CHIEF MEDICAL OFFICER

**Salary Scale :** 93150-15x2170-125700 (U-MO 2)

**Qualifications :**

A Medical Degree of a recognized university with prescribed Postgraduate qualifications and at least 12 years' experience as a Medical Practitioner.

**Note :** 1. The candidate should be registered as a Medical Practitioner at the Sri Lanka Medical Council.

2. Provision of accommodation facilities to the selected candidate may be considered.
3. The holder of the above post after confirmation in the appointment will be eligible for Sabbatical Leave as per provisions of Commission Circular Letter No. 408 and subsequent amendments.
4. Medical Practitioner in the service of Government/ Corporations and those who are presently serving in the State Sector on selection are required to obtain their release through the Ministry of Health or the relevant Corporation.
5. Payment of Research allowance will be considered (35% of basic salary) as per UGC Establishments Circular letter No. 05/2014 dated 30.05.2014 and subsequent amendments.
6. Communication facilities will be provided as per the Commission Finance Circular letter 07/2020 of Ministry of Finance.

**Qualifications :**

A Medical Degree of a recognized university with at least three (03) years' experience as a Medical Practitioner.

**Note :** 1. The candidate should be registered as a Medical Practitioner at the Sri Lanka Medical Council.

2. Provision of accommodation facilities to the selected candidates may be considered.
3. The holder of the above post after confirmation in the appointment will be eligible for Sabbatical Leave as per provisions of Commission Circular letter No. 408 and subsequent amendments.
4. Medical Practitioner in the service of Government/ Corporations and those who are presently serving in the State Sector on selection are required to obtain their release through the Ministry of Health or the relevant Corporation.

The selected candidates will become contributors to the Universities Provident Fund as well as the Universities Pension Scheme, the contributions being 10% from the employee to the Provident Fund and 7% and 8% from the employer to the Provident Fund and Pension Fund respectively. Further contribution of 3% will be made by the employer to the Employees Trust Fund.
