01. Project Description:

A tripartite agreement has been signed between the three parties, Ministry of Urban Development and Housing (on behalf of the Government of Sri Lanka), Urban Development Authority (UDA) and CHEC Port City Colombo Pvt. Ltd. (project company) for implementation of the Colombo International Financial City Project (Port City Project). Under this tripartite agreement, a great deal of responsibilities falls on the Government of Sri Lanka. The Ministry has set up a Project Management Unit for coordination, management, observation, and supervision of the responsibilities assigned to the Government of Sri Lanka.
