PRODUCT MANAGER – CARD BUSINESS

It initiates product ideas and ongoing features/benefits tailored for each target segments. Needs to collaborate moderate complex aspects of projects. The role is generally independent and collaborative in nature with multiple stakeholders.

The position of Product Manager – Card Business is equivalent to the grade of Manager (3-I) in the Bank. The key responsibilities involved in the position among others are,

- Develop and initiate portfolio management strategy to drive increase in billings, annual net revenue (ANR) and revenue across all card products.

- Working closely with International card schemes and other partners including business intelligence providers to understand global and local trends, market dynamics and competitive strategies to help grow the banks cards business.
- Manage retention and develop proactive and reactive retention /win back programs.
- Develop the outbound telemarketing strategy to cross sell to retail bases and implement Loan on Card, Instalments /Easy Pay Plan and Balance Transfer across the customer segments.
