**RECRUITMENT FOR THE POST OF**  
**DIRECTOR GENERAL**

Applications are invited from applicants possessing following qualifications for the post of Director General (HM 2-2) in Sri Lanka Export Development Board established by the Sri Lanka Export Development Act No. 40 of 1979 functioning under the Ministry of Trade.

**Qualifications**

**(a) For external applicants**

- (i) A Bachelor's Degree recognized by the University Grants Commission, relevant to subjects, Marketing / International Relations / Economics / Commerce / Science / Agriculture / Business Administration  
with  
Post graduate qualifications in the relevant field  
**and**

Should have a minimum of 20 years management level experience after obtaining the Bachelor's Degree of which 05 years should be of Senior Management Level Post in a Corporation, Statutory Board / Institute or Reputed Private Organization.

**or**

- (ii) Possessing a Bachelor's Degree recognized by the University Grants Commission, relevant to subjects, Marketing / International Relations / Economics / Commerce / Science / Agriculture / Business Administration  
and  
PhD Degree relevant to any field  
**and**

Should have a minimum of 05 years service experience after obtaining the Bachelor's Degree which should be of a Senior Management Level in a Corporation / Statutory Board / Institute or a reputed private organization.

**b) For Internal Applicants**

Having completed a satisfactory service of 02 years in a Senior Management Level post (HM 2-1) in Sri Lanka Export Development Board

**and**

Should possess an experience in the efficient implementation of powers, duties and work of Sri Lanka Export Development Board and proper application and efficient management of human and other resources.

**C) For Officers of Public Service**

Since officers in Class One or above in Sri Lanka Administrative Service could be appointed on secondary basis to perform the powers, duties and work of Sri Lanka Export Development Board they could apply.

**Salary Scale (HM 2-2) :** Rs. 93,020/= 12 x 2,700 = Rs. 125,420/= (Per mensem) and Government approved allowances.

**Age :** Should not be less than 35 years and not over 55 years. The maximum age limit will not apply for internal applicants and candidates from State Departments, Corporations and Statutory Institutes.

**Other qualifications :**

- All applicants should be of Sri lankan citizens.
- Should be of sound mental and physical position to serve any part of the island.
- Should be of good moral character.

**Other benefits entitled for the post**

- ❖ A vehicle will be released for official duties as per Circular No. PED 1/2015/(i) dated 27.10.2016.
- ❖ Medical aid scheme of the Export Development Board
- ❖ Payments for unavailed medical leave
- ❖ Housing and distress loans under government approved relief interest rates.
- ❖ 10% from the employee and 15% from the Board for Employees Provident Fund and 3% from the Board for Employees Trust Fund.
