The Public Utilities Commission of Sri Lanka (PUCSL) was established by the Act No. 35 of 2002 as a multi-sector infrastructure regulator in the country. With the enactment of the Sri Lanka Electricity Act No. 20 of 2009, the Commission became the economic, safety and technical regulator of the Electricity industry. PUCSL is the designated regulator for petroleum industry and has been assigned as the shadow regulator for lubricant market in Sri Lanka.
