VACANCIES

Applications are invited from citizens of Sri Lanka having qualifications and experience specified below and preferably having worked previously in Government or private large projects for the following posts on fixed term contract basis for the Moragolla Hydropower Project (MHP).

1. ENVIRONMENTAL OFFICER – One (01) Vacancy

1.1 Qualifications and Experience:

- First Degree in Physical Science, Biological Science, Environmental Science, Natural Resources Management, Forestry, Agriculture or any other related field obtained from a recognized University.
- Postgraduate qualification in Environmental Science or any related field with experience in **Health, Safety & Environmental (HSE)** Monitoring, Watershed Management or any related activity will be an added qualification.

1.2 Professional Competencies:

- Ability to deliver technical services related to Environmental Impact Monitoring and suggest mitigation measures as required by the project as and when necessary.
- Ability to handle project HSE related activities in the required area of specialization independently.
- Ability to function effectively in a team environmental inspiring trust and co-operation of other team members.
- Experience in handling the social safeguard issues related to Resettlement and Environmental impacts.
- Computer literacy of standard computer applications such as Word processing, Excel and Power Point presentations.
- Ability to communicate effectively.
- Good public relations skills.
- High level of proficiency in written and spoken English.
- Proficiency in written and spoken Chinese language will be an added advantage.

1.4 Duties:

- The Environmental Officer shall assist the Project Director/Project Engineer (REM) in the implementation of the Environment Management Plan of the project, the monitoring requirements specified in the National Environmental Regulations No. 1 of 2003 and site-level Health and Safety Monitoring.

2. LAND OFFICER - One (01) Vacancy

2.1 Qualifications and Experience:

- Diploma or any other higher qualification in a relevant field from a recognized Government Institute with G.C.E (Advanced Level) and overall experience of 05 years out of which at least 03 years should be in land acquisition and related work.

2.2 Professional Competencies:

- Preparation of all relevant documents pertaining to land acquisition.
- Co-ordination of land acquisition work with relevant agencies.
- Preparation of plan for granting deeds for people in the resettlement village and ensure each stage of the process is completed on time.
- Ensure all the acquired lands for the project are properly vested to CEB (Except lands given to resettlers) upon completion of the project.
- Computer literacy of standard computer applications such as AutoCAD, Word processing, Excel and Power Point presentations.
- Ability to communicate effectively.
- Good public relations skills.
- High level of proficiency in written and spoken English.
- Proficiency in written and spoken Sinhala and Tamil will be an added advantage.

3. CIVIL SUPERINTENDENTS - Two (02) Vacancies

- Possess a National Diploma in Technology in Civil Engineering of the University of Moratuwa.

National Diploma in Engineering Science (NDES) – IET Katunayake

Or

Diploma in Technology – OUSL

Or

Higher National Diploma in Engineering (HNDE) – Mattakkuliya and Labuduwa.

- Minimum 3 years of post-qualifying work experience in Hydropower Projects and/or major construction projects in Sri Lanka or abroad is compulsory.

3.2 Professional Competencies:

- Ability to read and understand civil construction drawings, working drawings, shop drawings and any other relevant technical details.
- Ability to read, understand and implement technical specifications.
- Ability to work in tough working environment such as dam, tunnels and powerhouse.
- Ability to work on day and night shift basis.
- Ability to supervise all types of work onsite to ensure required quality and productivity.
- Computer literacy of standard computer applications such as AutoCAD, Word processing, Excel and Power Point presentations.
- Physically fit and able to walk around for long periods of time at the site.
- Good public relations skills and ability to communicate effectively.
- High level of proficiency in written and spoken English.
- Proficiency in written and spoken Chinese language will be an added advantage.

3.4 Duties:

- The Civil Superintendent shall assist the Project Director/Project Manager (Civil)/Consultants and all the Civil supervision work related proceedings of Moragolla Hydropower Project.

This maximum age limit will not be applicable to those who are already confirmed in the Public Service/Public Institutions.

Terms & Conditions of Service:

The appointment will be on contract basis for one(01) year term subject to renewal annually based on satisfactory performance. The contract may be extended for further term depending on the requirement of the project.

Other Benefits:

1. Those selected will be entitled to Employees' Provident Fund (EPF) with Employee's Contribution of 10% and CEB Contribution of 15%.
2. Employees' Trust Fund (ETF) Contribution of 3% by the CEB.

Those applicants who are already in the Public Service/ Public Institutions should forward their applications through their Heads of Departments and it should herein be indicated whether the release is possible in case of selection for the post.

All applicants should include a complete CV with names, contact numbers and addresses of two non-related referees, certified copies of the Educational & Professional Qualifications, Experience, Training certificates, NIC, Birth certificate and any other relevant documents.
